### **5 CORRESPONDENCE**

ELC have been working with Wessex Water to seek compensation as the proposed sewage main could be going through their land. LP advised that the Parish Council would not be happy if the ELC scuppers the proposed sewage main as they have fought for this for nearly a decade.

Also the ELC are pursuing full retail on their site as their thoughts are this will not make any difference to the traffic as it would more than likely large sales such as 100 trees for one client to pick up. LP was concerned that this may not be the case and there could equally be 100 clients colleting one tree each.

It was agreed to write to SSDC Planning to advise that the parish is against the thought of retail and the majority of the Parish Council are against the complete application. A letter would be drafted and sent to Simon Fox asking for confirmation of receipt stating that the road is not man enough for more than the amount of traffic that currently uses the lane.

ELC have also reported that they have renamed the area to Wyvern Paddock.
